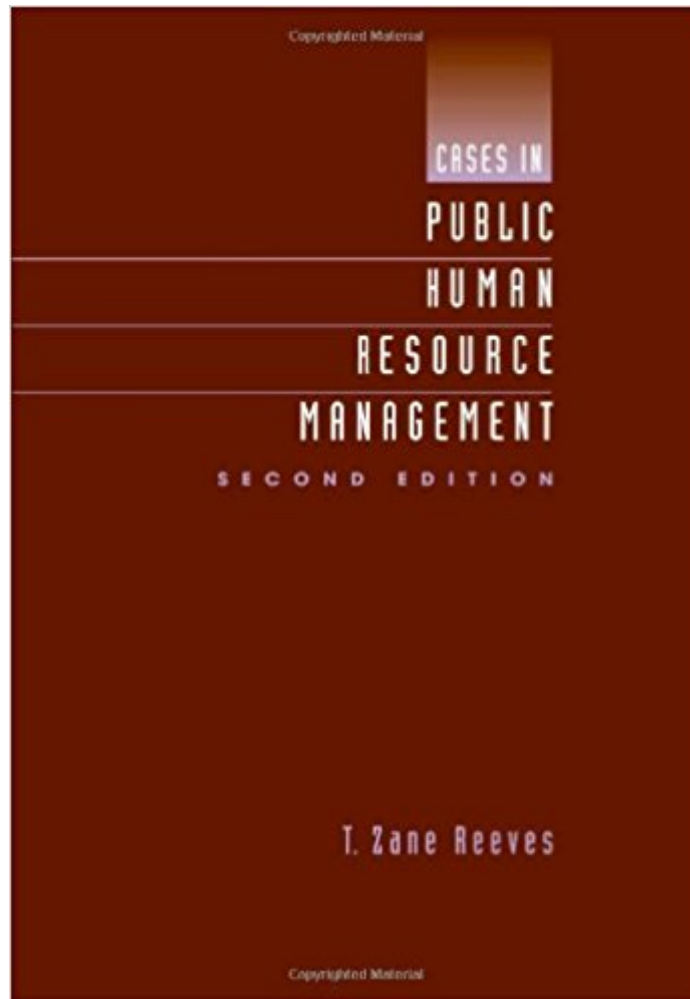

This was a great book of case studies I used for a human resources management class. A lot of the cases were actually pretty interesting to read about. The only downside was that it left a hanging conclusion after each case so that you wouldn't know the end result, but that wasn't too bad since it left room for discussion in class. I would highly recommend this book.

I used this casebook for the first time in a graduate-level public sector human resource management course in the Spring of 2007. I essentially structured the course around the case studies, using a basic survey text as a supplement. The student response was strongly positive. I had them do weekly writing assignments based on the cases, and we started each class meeting by discussing

the cases. This approach made the subject matter much more real and practical to the students, and as a result they all excelled. If I have any criticisms of the book, they are: 1) many of the cases that are labeled as something other than a disciplinary matter are actually disciplinary matters. So there is less variety to the cases than a look at the table of contents indicates. 2) For such a slim book, the price tag is quite high!

I had to use this book as a companion for Human Resource Management in Public Service. This little book adds some interesting and challenging insights into the challenges of HR management in public service agencies.

This text offered 30 thought provoking topics for the pending manager. There were things I hadn't considered and things I added to with my experiences. Good brief reads, Reader's Digest styles
