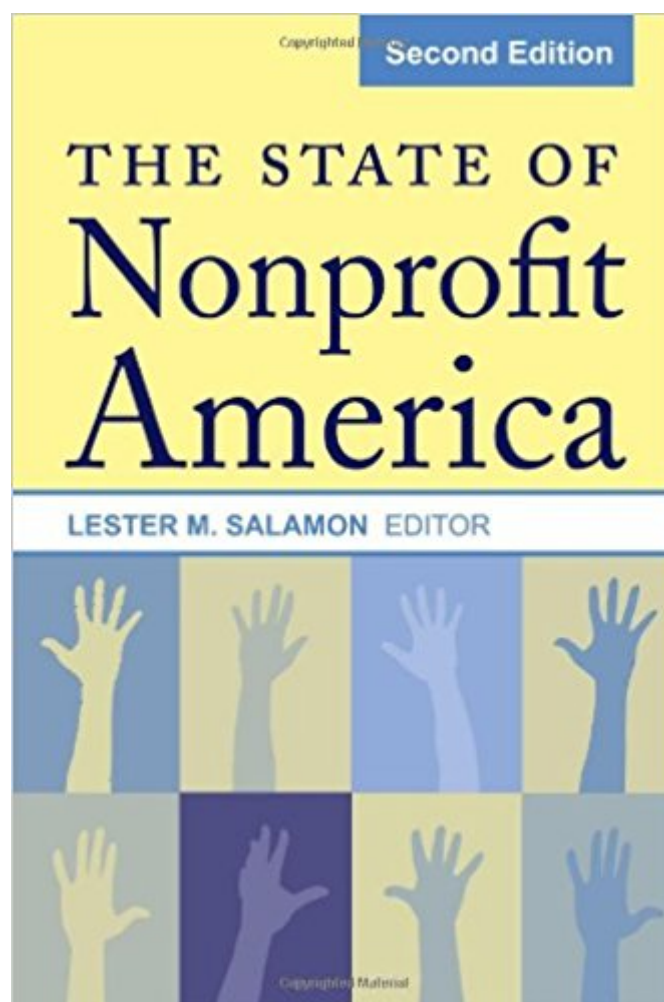

Synopsis
